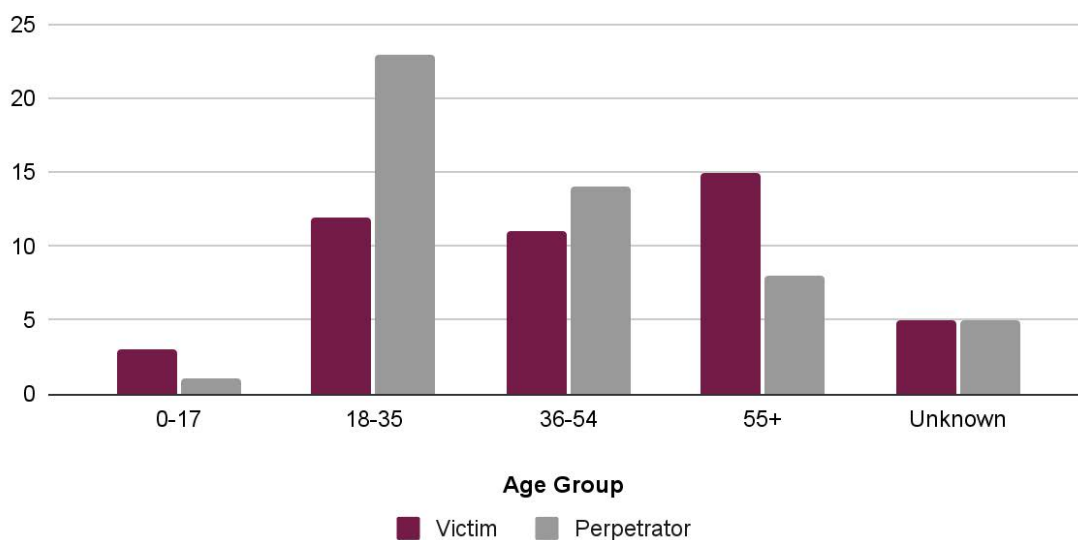

Victim and Perpetrator Age Comparison



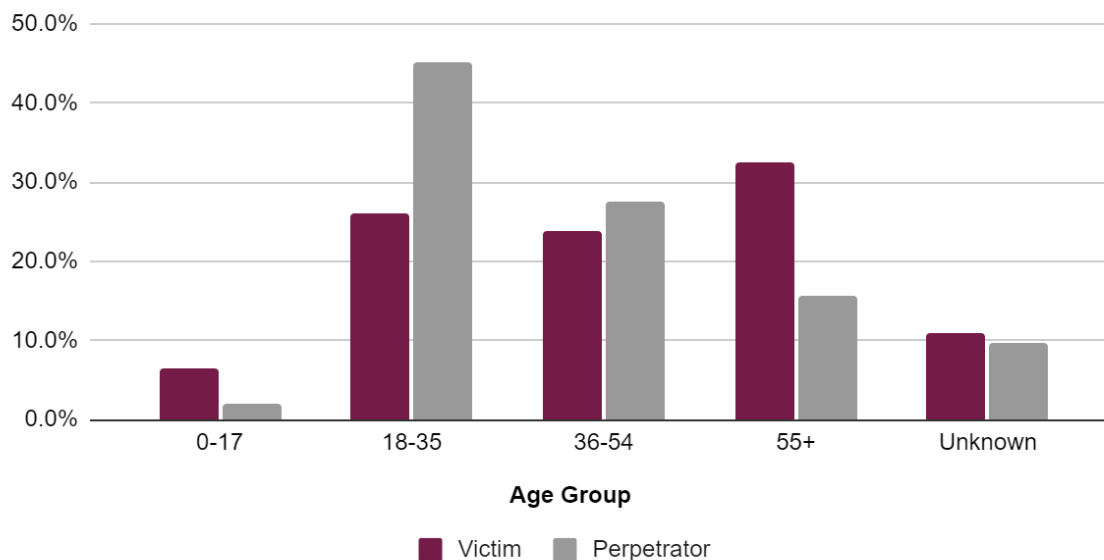

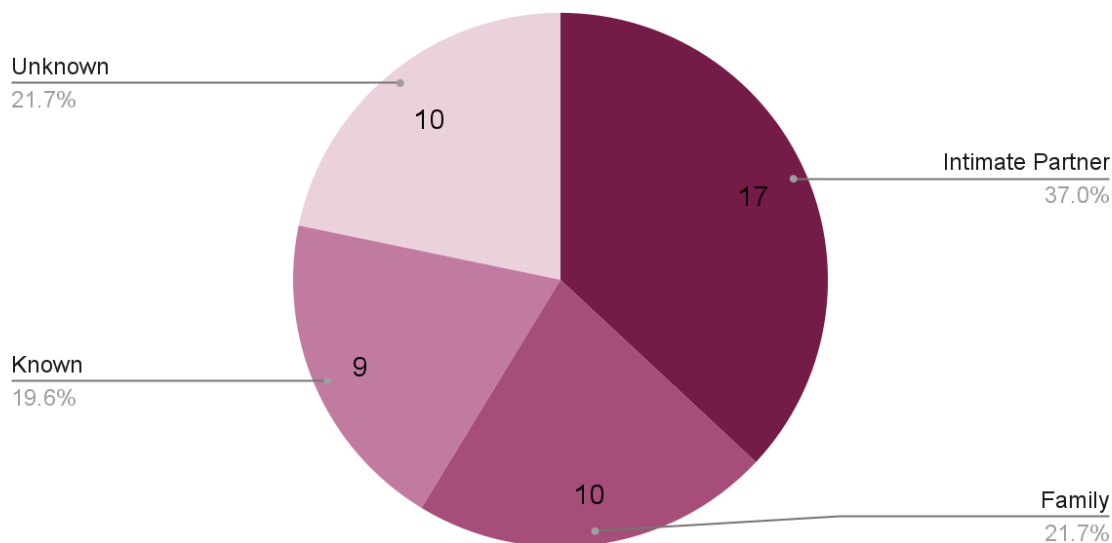

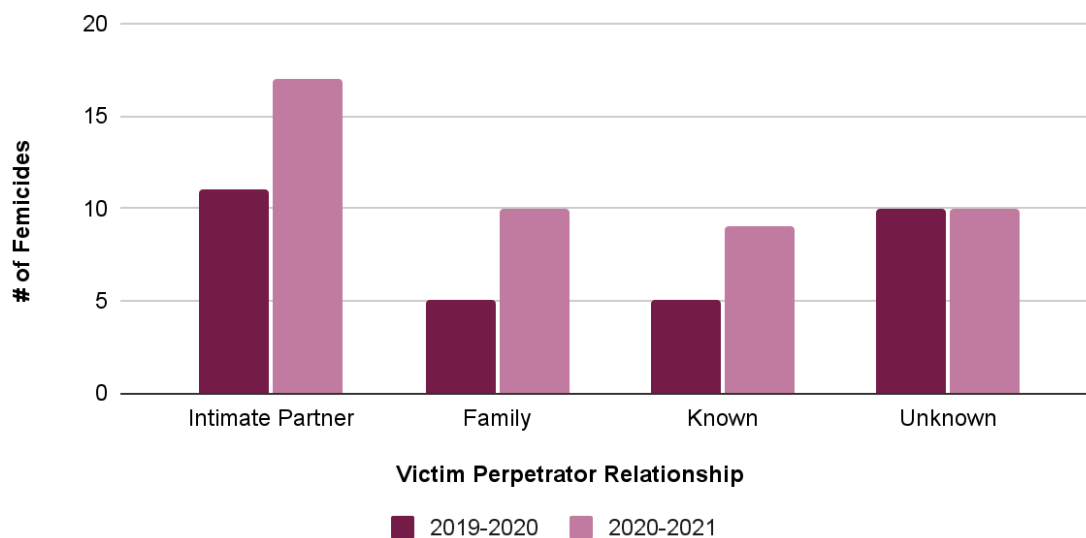


Victim Perpetrator Relationship 2019-2020 & 2020-2021

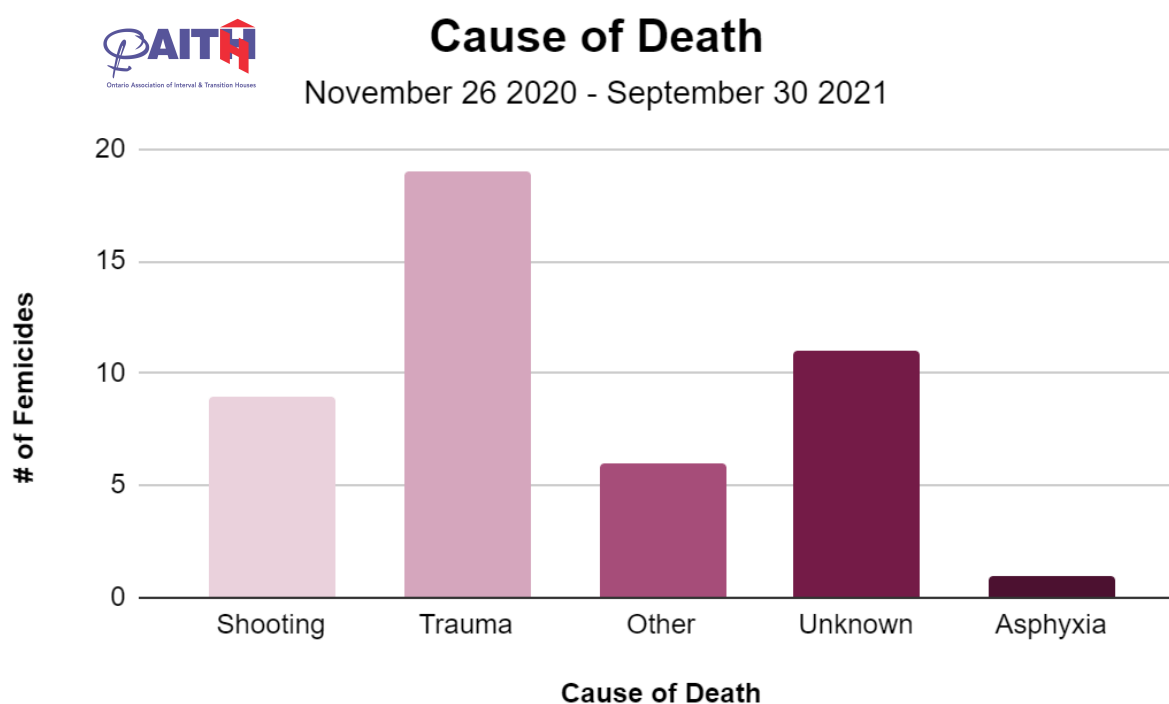
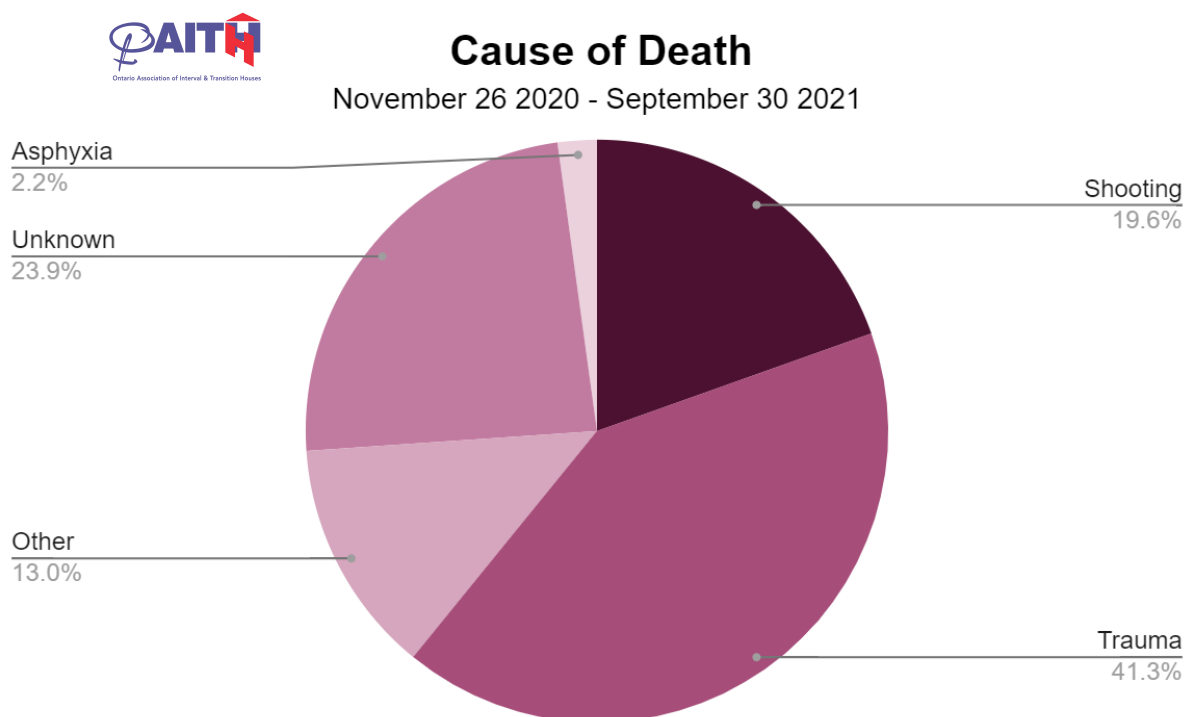

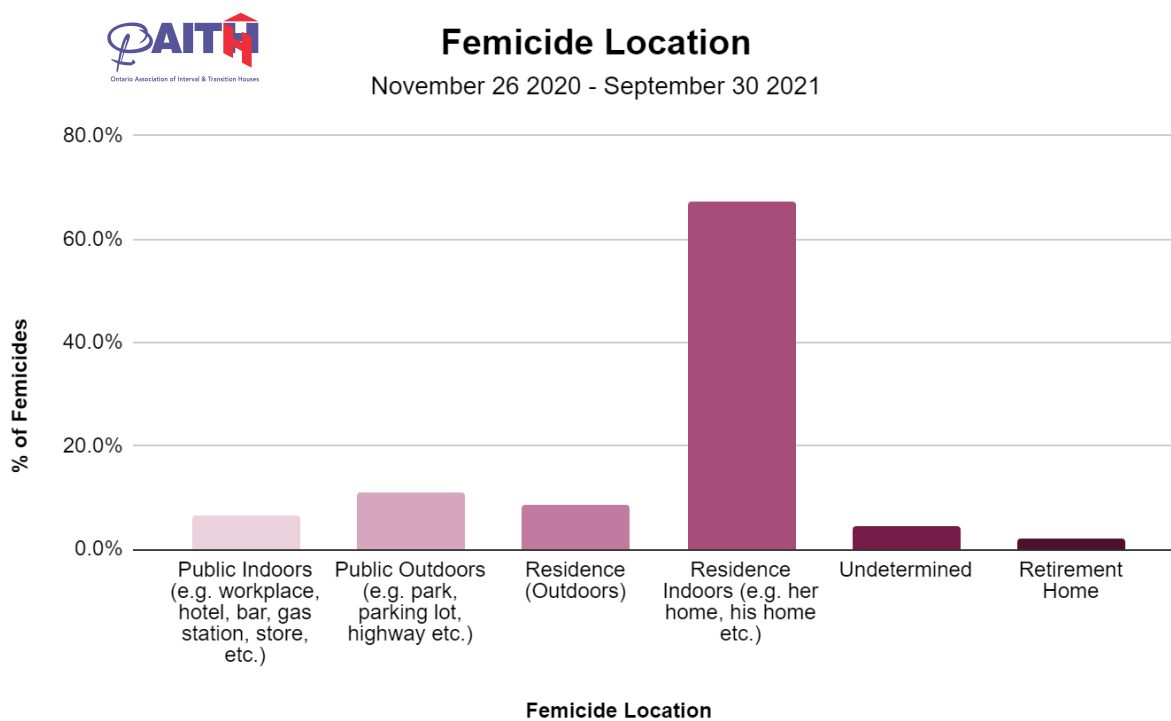
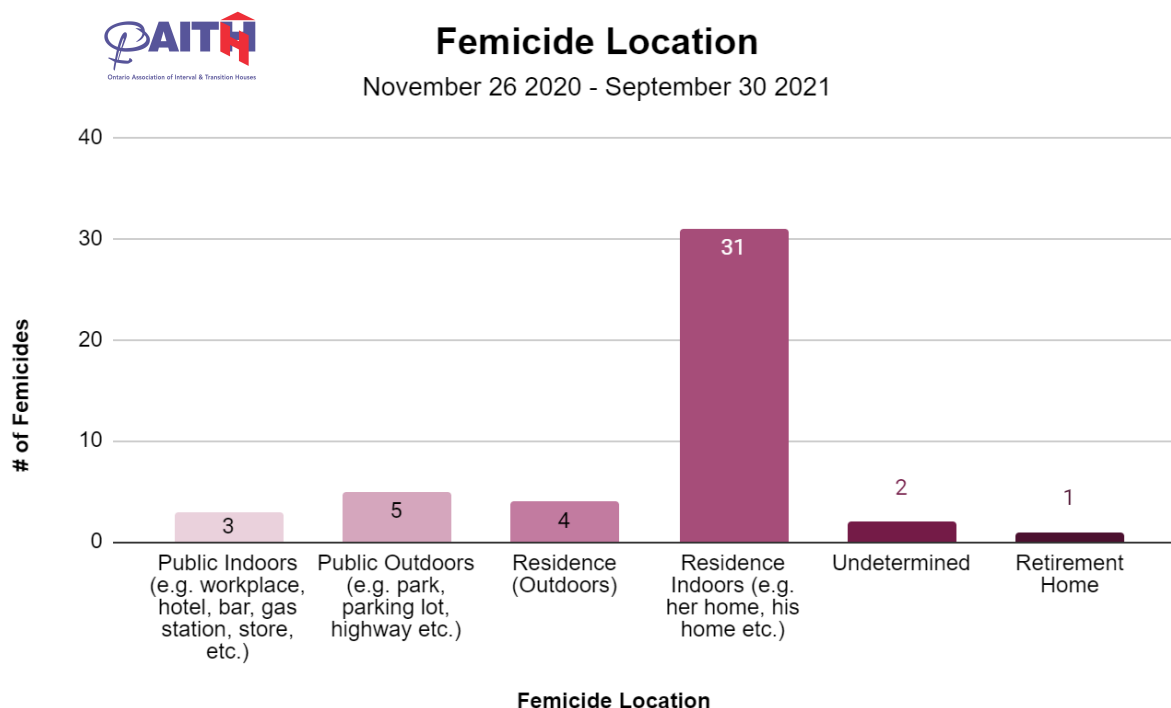


Cause of Death

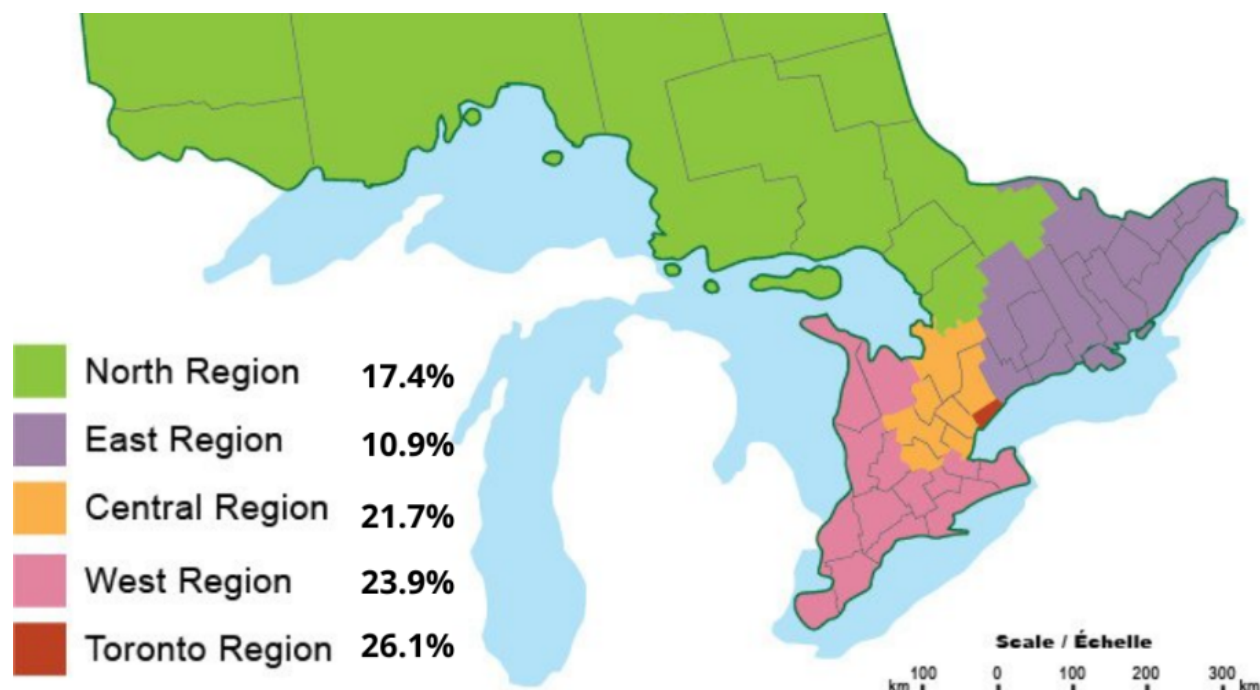

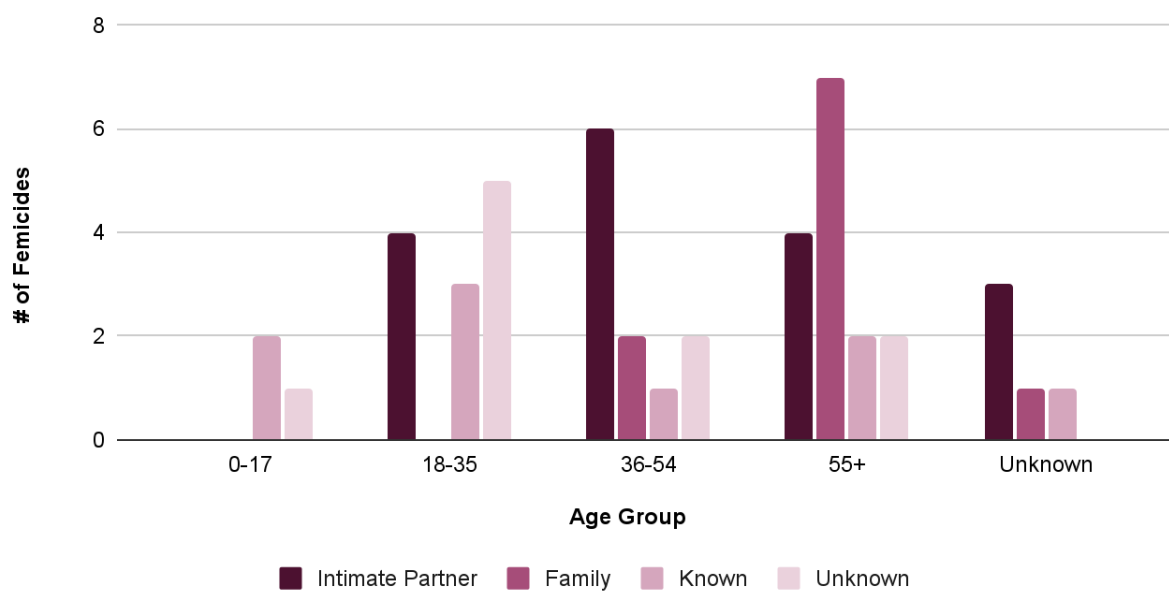

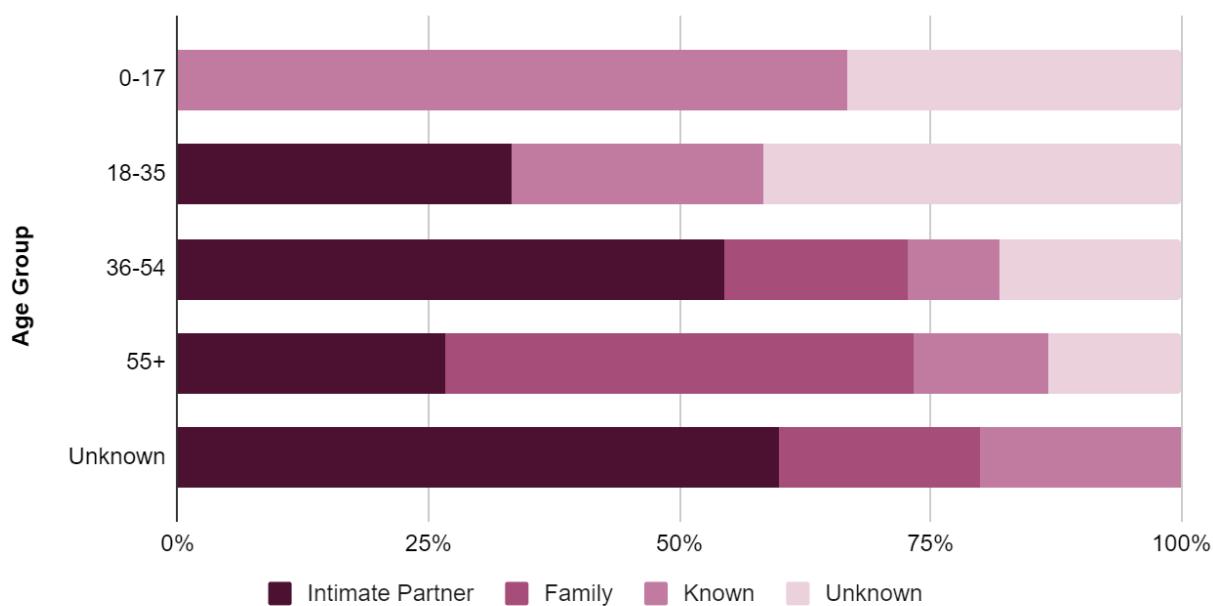

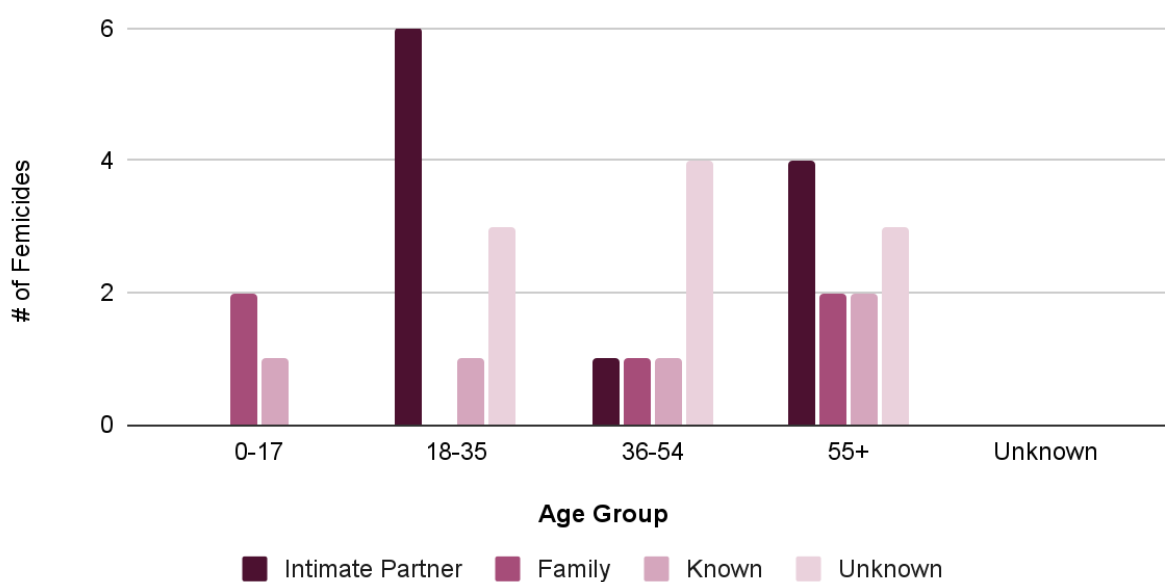


Nov 2019 - Sept 2020 Victim Age and Perpetrator Relationship Comparison

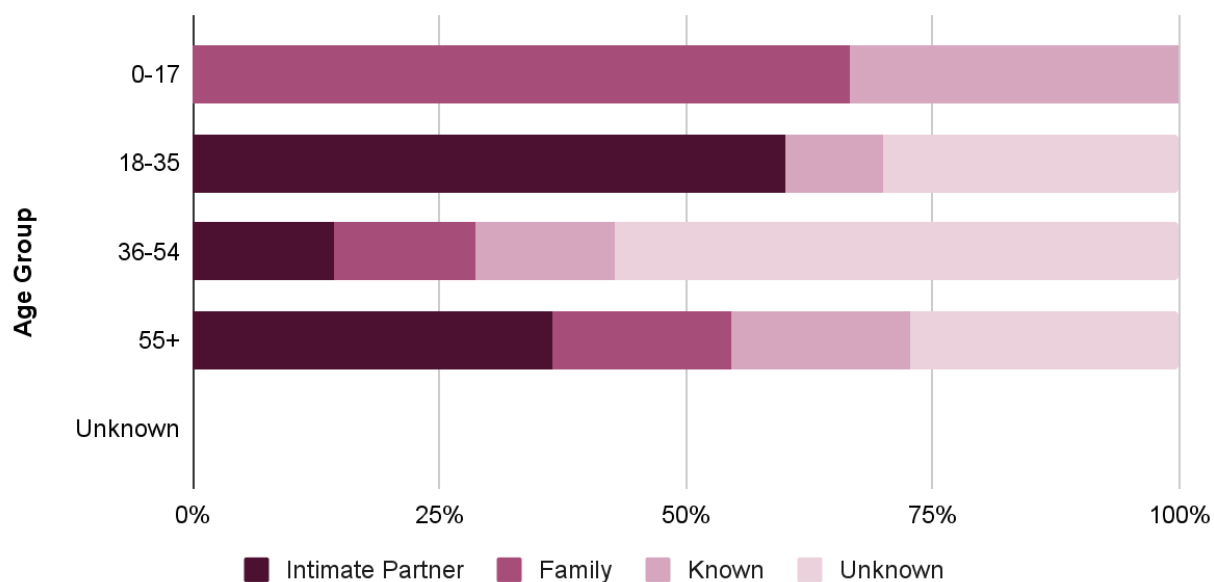

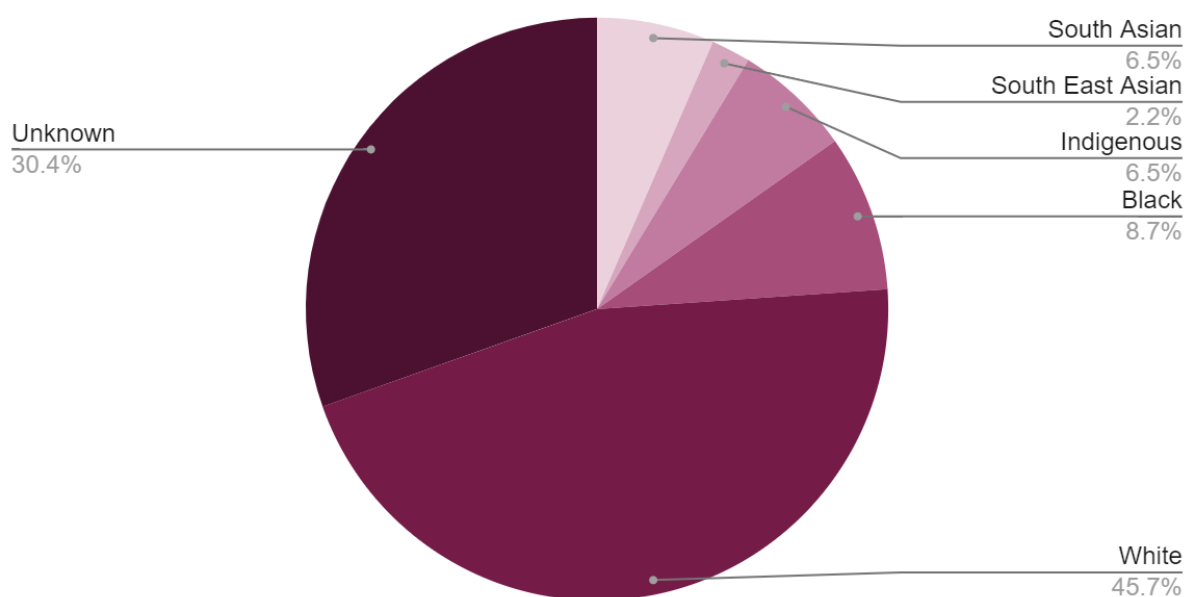

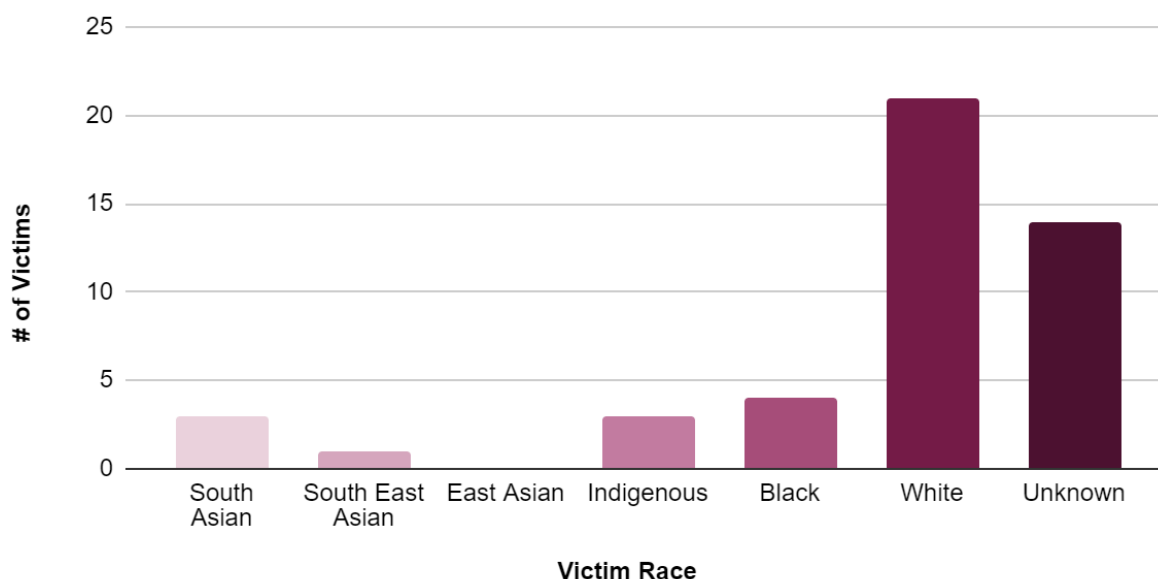

Femicide Cases

Cileana Taylor

In September 2020, Cileana Taylor, from Curve Lake First Nation, was assaulted by her boyfriend Jordan Morin. As a result of the injuries sustained in the assault, Cileana suffered severe brain damage and was taken off life support in February 2021¹. According to media reports, the accused, Jordan Morin, has had a number of previous criminal convictions for assault² and at the time of the September assault was reportedly on bail for a previous assault charge from 2019.³ He was again charged in September 2020 following the assault on Cileana, with aggravated assault and assault causing bodily harm. Following this arrest, Morin was once again released on bail. Media reports have indicated that since that release, Morin has been arrested for breach of conditions, as well as “two counts of domestic assault, assault causing bodily harm (choking) and mischief under \$5,000” stemming from an incident that took place in November 2020.⁴

- Two previous assault charges
 - 2015
 - 2019
- Arrested in September 2020 for the assault of Cileana Taylor, his girlfriend
 - Media reports indicate he was on bail for the 2019 assault at the time of this incident
 - He was released on bail for the 2020 assault on Cileana Taylor
 - Taylor died as a result of her injuries in February 2021
- In November 2020 Morin is arrested for breach of conditions
 - Media reports indicate he plead guilty and was released
- February 2021, Morin was charged with two counts of domestic assault, assault causing bodily harm (choking) and mischief under \$5,000 stemming from a domestic assault that took place in November 2020
- Cileana Taylor was an Indigenous woman from Curve Lake First Nations Reserve

Hanadi Mohammed

In June 2021, Hanadi Mohammed and her adult daughter were attacked by Hanadi's estranged husband, Hamid Ayoub. Hanadi's daughter survived the attack, however, Hanadi died as a result of the injuries she sustained in the attack. Media reports have confirmed with police that Hanadi had called the police several months earlier, regarding an incident that had occurred between herself and her estranged husband. According to police reports, the incident "did not meet the "criminal threshold """, and Hanadi was provided with instructions on how to obtain a restraining order.⁵ Media reports indicate that Hanadi tried to obtain a restraining order in relation to ongoing stalking and abusive behaviour by her estranged husband three months prior to this attack, but was unsuccessful.⁶ It is unclear on whether or not any additional follow up was done with Hanadi following her initial call to police, but it is clear her death was preventable.

- Hanadi Mohammed was murdered by her estranged husband
 - Hanadi's adult daughter was injured in the attack but has survived
- Hanadi had called police several months prior to her murder in relation to a domestic violence incident with her former spouse
 - No charges were laid
 - Victim was provided information on obtaining a restraining order
 - The victim was unsuccessful in obtaining a restraining order
- Hanadi Mohammed was an older woman, as well as an immigrant from Sudan
